1.	<p>Application for Tamil Nadu State 2025-2026 UG (BSMS / BAMS / BUMS / BHMS) Medical Course for Government seats and Government Surrendered seats can only be submitted online through Tamil Nadu AYUSH Selection Committee websites: <a href="http://www.tnhealth.tn.gov.in">www.tnhealth.tn.gov.in</a>, <a href="http://www.tnayushselection.org">www.tnayushselection.org</a>. Application submitted through any other mode shall not be entertained.</p>
2.	<p>a. The registration fee for the application form is Rs.500/- (Rupees Five Hundred Only) (non-refundable) and it should be paid through online Bank payment portal in the website. The candidates applying under Special category for Children of Ex-Servicemen, Eminent Sports Person, Person with Bench mark Disability (PwD) and Union territory of India (UTI) should pay an additional fee of Rs.100/- (non-refundable) for each special category via Bank payment portal.</p> <p>b. All Scheduled Caste/ Scheduled Caste (Arunthathiyar) / Scheduled Tribe candidates of Tamil Nadu native are EXEMPTED from payment of the cost of the application.</p> <p>c. The last date for submission of online application form will be upto 5:00 P.M. on 08.08-2025. Thereafter there is no provision for the candidates to submit their online application form.</p> <p>d. Candidates should fill up all mandatory columns, upload all required documents and submit the duly filled in online application. The candidates may download their filled in online application form and secure a copy of the same for their future reference. Subsequent submission of supporting document(s), is not accepted either on courier / post / or in person.</p>
3.	<p><b>(a)</b> Qualified and eligible candidates are required to register ONLINE on the Tamil Nadu Ayush Selection Committee website <a href="http://www.tnayushselection.org">www.tnayushselection.org</a> to participate in the counselling process for allotment of seat. Tamil Nadu Ayush Selection Committee does not allot any seat manually. 4.	<p>The admissions in the State of Tamil Nadu are as per the provisions of the Government of Tamil Nadu and in compliance to the National Commission for Indian System of Medicine (NCISM) and the National Commission for Homoeopathy (NCH) and shall be solely based on marks obtained in the National Eligibility-Cum-Entrance Test (NEET (UG) – 2025) conducted by National Testing Agency (NTA).</p>
5.	<p>As per Chapter-6, Clause 6.6 para (2) of the NEET Information Bulletin 2025 issued by the National Testing Agency, the Reservation of the Seats in the AUSH Colleges for respective categories shall be allotted as per applicable laws prevailing in the State of Tamil Nadu.</p>
6.	<p>As per amended Regulations, the seat matrices for admission in the Government and Self-Financing Institutions shall <b>be 15% for the All India Quota and 85% for the State Quota for the academic year 2025 - 2026.</b> Further Apportionment of seats between Government and Management of Self-Financing Minority and Non-Minority Indian Medicine and Homoeopathy Medical Colleges will be as per existing State policy and National Commission for Indian System of Medicine (NCISM) and National Commission for Homoeopathy (NCH) regulations and applicable Court orders.</p>
7.	<p>Counselling to Government School students under 7.5 % reservations (as per the Tamil Nadu Admission to Under graduate Courses in Medicine, Dentistry, Indian Medicine and Homeopathy on preferential basis to students of Government schools Act, 2020 (Tamil Nadu Act No.34 of 2020) will be done ahead of the General Category. The candidate has to appear in person along with the relevant original certificate at the Selection Committee Office for counselling.</p>

**Note for Special Category Claim:**

- i. Special Category (Children of Ex-Servicemen, Eminent Sports Person, Persons with Bench mark Disability, Union Territories of India and Heirs of Hereditary IM practitioners) are instructed to submit their application in online only.
- ii. One candidate can apply a maximum of three Special Categories. For each special category Rs.100 / - has to be paid separately through online portal. The claim under Special Category will not be considered, under any circumstances without the required documents.
- iii. Special category rank differs completely from that of the General Category rank.
- iv. Special category candidates cannot claim the same rank in the General category and vice versa.

1.	<b>ELIGIBILITY CRITERIA</b> Candidate should be a citizen of India.
2.	<b>NATIVITY</b> <ul style="list-style-type: none"><li>i. Candidate should be a Native of Tamil Nadu.</li><li>ii. Other State candidates who have studied from VI Standard to XII Standard continuously in Tamil Nadu, have to produce their School Bonafide Certificate from the School in which candidate studied VI standard to XII standard will be considered under the Open Category.</li></ul> <p><b>Note:</b></p> <ul style="list-style-type: none"><li>a. Candidates who are native of Tamil Nadu studied from VI to XII Std. either partly or completely in schools situated outside Tamil Nadu should upload the “Nativity Certificate”. Such candidates should also give an undertaking that they have not applied for any Educational Institution in any other State, claiming the nativity of such State for admission. If it is found later that the candidate has applied as a native of any other State other than Tamil Nadu, then the admission will be cancelled at any stage. Further, even during the course of study if it is subsequently found they any candidate has produced a false nativity certificate or given a false undertaking, it will result in expulsion of the candidate from the course and also initiation of criminal proceedings against the candidate as well as his/her parents as per provision of the law.</li><li>b. The Certificate of Nativity in Tamil Nadu should be issued by the competent authority only in the specified format available (ANNEXURE IV) in the Prospectus.</li><li>c. Applications without a proper Nativity Certificate will not be considered.</li><li>d. Candidates belonging to other States and residing in Tamil Nadu cannot claim nativity of Tamil Nadu.</li><li>e. Permanent Residence Certificate in lieu of Nativity Certificate will not be accepted.</li><li>f. Foreign Nationals are NOT eligible to apply for admission to B.S.M.S./B.A.M.S./ B.U.M.S. / B.H.M.S courses 2025 - 2026 session.</li><li>g. Producing false nativity certificate if detected at any time later during the course of study will result in expulsion of the candidate and also initiation of criminal proceedings against the candidate as well as the parents as per law.</li></ul>

3.	<p><b>AGE LIMIT (For Details kindly refer clause 5.1.1. of NEET UG – 2025 Bulletin)</b></p> <p>No candidate shall be admitted to BSMS / BAMS / BUMS / BHMS Degree Course unless one has attained the age of <b>Seventeen Years</b> on or before the <b>31<sup>st</sup> December, 2025</b> of his/her admission to the first year of the undergraduate AYUSH courses and there is no upper age limit. (Evidence for the age e.g. birth certificate, 10<sup>th</sup> mark sheet should be uploaded).</p>												
4.	<p><b>COMMUNITY CERTIFICATE:</b></p> <p>a. 5.	<p><b>EDUCATIONAL QUALIFICATIONS</b></p> <p>(i) Admissions to all State Quota seats of Undergraduate Ayurveda, Siddha, Unani and Homoeopathy Courses will be done through NEET (UG) – 2025 as per the provisions of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education), Regulations 2022, National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Siddha Education), Regulations 2022 and National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Unani Education), Regulations 2022, and National Commission for Homoeopathy (Homoeopathy Graduate Degree Course – BHMS), Regulations 2022 NCISM (NATIONAL COMMISSION FOR INDIAN SYSTEM MEDICINE) &amp; NCH (NATIONAL COMMISSION OF HOMOEOPATHY) are Regulatory Bodies of the above-mentioned Courses under the Ministry of AYUSH).</p> <p>(ii) In order to be eligible for admission to BSMS / BAMS / BUMS / BHMS Degree courses for this academic year, it shall be necessary for a candidate to obtain minimum of marks at <b>50<sup>th</sup> Percentile</b> in NEET UG-2025. However, in respect of candidates belonging to Scheduled Tribes, Scheduled Castes, Scheduled Castes (Arunthathiyar), Backward Classes, Backward Classes (Muslim) and Most Backward Classes / Denotified Communities, the minimum marks shall be at <b>40<sup>th</sup> Percentile</b> in NEET UG-2025. In respect of candidates with Bench mark Disabilities specified under Rights of persons with disability Act 2016, the minimum marks shall be at <b>45<sup>th</sup> Percentile</b> for General Category candidates and <b>40<sup>th</sup> Percentile</b> for ST / SC / SCA / MBC / DNC / BCM and BC candidates in NEET UG-2025.</p>

**Note:**

Provided further that where sufficient number of candidates in the respective category fail to secure minimum marks in the National Eligibility – cum – Entrance Test held for any academic year for admission to undergraduate programme, the National Commission for Indian System of Medicine & National Commission for Homoeopathy, in consultation with the Central Government may at its discretion lower the minimum marks required for AUSH admission to undergraduate programme for candidates belonging to respective category and marks so lowered by the Central Government shall be applicable for that academic year only.

(iii) Further, to be eligible for admission to BSMS / BAMS / BUMS / BHMS Degree courses, Candidates must have passed in all the subjects of the qualifying examination of the Higher Secondary Certificate Examination (Academic) conducted by the Tamil Nadu State Board or any other equivalent Board with the subjects of Physics, Chemistry, Biology / Botany and Zoology / Bio-technology and English

(iv) **The Candidate shall have passed 10+2 (or equivalent) with Physics, Chemistry, Biology or Biotechnology.** The minimum standards of UG regulations stands withdrawn for eligibility criteria for ASU courses as per letter Ref. No BOA/2-B/UG/2025 dt. 11-07-2025 from Secretary NCISM.

**NOTE:** Candidates who have passed any other equivalent examinations with same subjects as mentioned above in clause **5 (iii)** should produce Migration certificate from respective Board / University; and Candidates who have passed any other equivalent examinations (i.e., other than the Tamil Nadu State Board / CBSE / ISCE) with same subjects as mentioned above in clause **5 (iii)** should produce the eligibility certificate from The Tamil Nadu Dr. M.G.R. Medical University at the time of admission in respective colleges.

(v) Candidates qualified in the NEET (UG) - 2025 and who have passed the qualifying examinations from *National Institute of Open Schooling or State Open Schools or as private candidates* from recognized State Boards; or with Biology / Biotechnology as an additional subject shall be allowed but subject to the outcome of Special Leave Petitions / Appeals filed by the Medical Council of India. **[As per NEET (UG) 2025 Guidelines]**

**Note:** \* *“The proviso in italics has been a subject matter of challenge before the Hon’ble High Court of Delhi, Hon’ble High Court of Allahabad, Lucknow Bench, and Hon’ble High Court of Madhya Pradesh at Jabalpur. The provisions of the regulations disqualifying recognized Open School Board candidates and the candidates who have studied Biology / Biotechnology as an Additional Subject has been struck down.”*

(v) **Language qualification for BSMS / BUMS Courses:**

(a) **FOR BSMS COURSE:** In addition to the required minimum percentile in the NEET UG- 2025

1. The candidate should have studied in Tamil medium upto X or XII Standard, or
2. The candidate should have studied Tamil as a subject upto X or XII Standard, or
3. The candidate must be prepared to pursue the study of Tamil Language as a subject during the First-year course of B.S.M.S. course, to become eligible to take the other subjects’ examination of the B.S.M.S. Course.

(b) **FOR BUMS COURSE:** In addition to the required minimum percentile in the NEET UG-2025. (As per Gazette notification CG-DL-E-02032022-233801, Part II – Section 4 dt. 28-02-2022)

1. The Candidate should have studied in URDU Medium upto X or XII Standard, or
2. The candidate should have passed Urdu/ Arabic / Persian as a subject upto X or XII Standard, or
3. The candidate must be prepared to pursue the study of Urdu Language as a subject during the First-year course of B.U.M.S. course, to become eligible to take the other subjects’ examination of the B.U.M.S. Course.

6. **INELIGIBILITY CRITERIA**

The following categories of candidates are **NOT ELIGIBLE** to apply for B.S.M.S. / B.A.M.S. / B.U.M.S. / B.H.M.S. Courses.

- a) Candidates who have passed Higher Secondary Certificate Examination in Vocational Stream or Pre-University Course in Tamil Nadu.
- b) The selection and admission of candidates of other than those in clause 5 (iii) will be provisional subject to recognition of the qualifying examination by the Tamil Nadu Dr. M.G.R. Medical University under which the candidate gets

admitted. In case, the recognition is not accorded for the admission of the candidate on any grounds, the provisional admission will not entitle the candidate for the continuance of the course and the admission will be cancelled.

c) Candidates presently pursuing the B.S.M.S. / B.A.M.S. / B.U.M.S. / B.H.M.S. Courses are **NOT ELIGIBLE** to apply for B.S.M.S. / B.A.M.S. / B.U.M.S. / B.H.M.S. Courses respectively, during this academic session.

d) **Candidates' native of other States and studied in other States.**

e) **Candidates declared ineligible by AACCC website are not eligible for further counselling after the date of announcement of ineligibility.**

7. **PROCEDURE FOR FILLING AND SUBMISSION OF ONLINE APPLICATION FORM:**

1. The candidates are advised to take a print out of the Prospectus from the official website and read it carefully, along with the parent / guardian before filling up the online application form for the academic year 2025-2026.

3. The application forms will be available online from 24-07-2025 onwards till 08.08.2025 upto 5:00 P.M.
4. The candidate should pay the non-refundable registration fee for online application cost of Rs.500/- (Rupees Five Hundred only).
5. Candidate has to fill all the mandatory columns in the online application. All the relevant documents should be uploaded in PDF format. Candidates are instructed to submit the online application after filling up all the required fields.
6. Request for change in any particulars after submitting the online application form shall not be entertained under any circumstances.
7. Candidates are instructed to upload the following certificates while filling the online application form and submit.
  - i. NEET- UG 2025 Admit card and Score card.
  - ii. Class X Mark Sheet (both sides of Certificate) / Birth Certificate
  - iii. Class XI Mark Sheet (both sides of Certificate).
  - iv. H.S.C. Mark sheet (both sides of Mark Sheet) or any other equivalent examination.

- v. Transfer certificate obtained after the completion of H.S.C. or equivalent examination/ or any other courses.

(ii) Further all admissions on preferential basis (7.5 percentage) [as per the Tamil Nadu Admission to Undergraduate Courses in Medicine, Dentistry, Indian Medicine and Homeopathy on preferential basis to students of Government schools Act, 2020 (Tamil Nadu Act No.34 of 2020)] to the Government School students counselling will be done ahead of the General Category. The candidates have to mention the EMIS number clearly.

- (iii) A separate rank list shall be prepared on the basis of the marks obtained in National Eligibility-cum-Entrance Test (NEET-UG 2025) for B.S.M.S. / B.A.M.S./ B.U.M.S. / B.H.M.S. Courses for the academic year 2025 -2026 for the Special Categories as well as the 7.5% seats allocated for the candidates seeking admission under the Tamil Nadu Admission to Undergraduate Courses in Medicine, Dentistry, Indian Medicine and Homeopathy on preferential basis to students of Government Schools Act, 2020 (Tamil Nadu Act No.34 of 2020). Further all admissions on preferential basis (7.5%) to Government School students and admissions for Special categories will be on horizontal reservation basis.

- b. At the time of choice locking candidate should pay refundable advance tuition fees of Rs.5,000/- (Rupees Five Thousand only) for both Government Quota Seats and Government Surrendered Seats in Self Financing ASUH Medical Colleges.
- c. **This advance tuition fees amount will not be refunded after allotment of seats in third round of counselling.**

- f. Candidates are instructed to register and Choice lock the seats for each Round of counselling within the stipulated date and time as mentioned in the counselling Schedule.

- h. Candidates could edit their choices but once the candidate locks their choices during the online counselling it cannot be changed later.

**I. ROUND 1 OF ONLINE COUNSELLING:**

- a. The candidates should pay a non-refundable amount Rs. 500/- (Rupees Five Hundred only) towards online processing fee and Advance Tuition Fee (Refundable up to Round 2) amount for Government Quota Seats and Government Surrendered Seats Rs.5,000/- (Rupees Five Thousand only) via online Bank payment portal.
- b. A candidate who has taken a seat and Not Joined/ discontinued the course within the stipulated time will be eligible to attend the subsequent Rounds of online counselling for the academic year 2025-2026.
- c. Re-allotment is permitted during the Round 2 and Round 3 of counselling based on rank following the rules of reservation.
- d. If a candidate fails to join the College within the stipulated time, in the Round 1 or Round 2 of counselling candidates will be permitted to participate in the Round 2 or Round 3 of online counselling respectively.

## **II. ROUND 2 OF ONLINE COUNSELLING:**

- a. Candidates who had locked their choices Round-1 and did not get any seat allotted are not required to lock their choice again. Also, candidates who have allotted the seat in Round-1, but not joined in the college need not lock their choice again. Candidate who have allotted the seat in round-1 and joined the college and wish to opt for upgradation need not lock their choice again.
- b. Fresh choice filling is permitted in this Round for those candidates who have not locked their choices in Round-1 (with the payment of processing fee and advance tuition fee).
- c. Candidate who wishes to retain their seats (who don't want a change in college) need not participate in Round-2.
- d. If upgraded in Round 2, the candidate has to relinquish the seat from Round 1 and join the seat allotted in Round 2.
- e. Candidates should be careful while choice filling and it is advisable to choose preferred colleges only.
- f. Candidate could edit their Choice(s) but once the candidate locks their choice(s) during the online counselling, it cannot be changed later.
- g. If the candidate is reallocated in Round 2, then the BSMS / BAMS / BHMS seats allotted to candidates during Round 1 of Counselling will be allotted to other candidates in descending order, not in ascending order.
- h. A candidate who has taken a seat and not joined/ resigned the course within the stipulated time will be eligible to attend the subsequent Rounds of online counselling for the academic year 2025-2026.
- i. If the candidate has joined but Discontinued the course after the stipulated date of resignation he /she will be eligible to attend the Round-3 of online counselling for the academic year 2025-2026, but they will have to forfeit the registration fee and tuition fees paid by him/her.

### **III. ROUND - 3 OF ONLINE COUNSELLING:**

When a candidate is scheduled to attend the Round-3 online counselling, then the candidate has to pay the Processing Fee of Rs.500/-(non-refundable) via online Bank payment portal. The candidates who have already paid the Processing fees during previous Rounds of counselling need not pay again if they have not been allotted seats.

- e. Once the candidate joins the seat allotted in Round 3, he/she cannot upgrade or resign from this seat.
- f. If any candidate does not join the Round 3 allotted seat, candidate will have to forfeit the online processing fee, advance tuition fees paid by him/her. And they will also be not eligible to participate in the subsequent Rounds of counselling.

#### IV. STRAY ROUND OF COUNSELLING:

- a. Stray vacancies if arises after the third round of Counselling. Stray vacancy counselling will be conducted by the Selection Committee as per the directions of the Commissioner of Indian Medicine and Homoeopathy and also as per the guidelines of NCISM (National Commission for Indian System Medicine) / NCH (National Commission of Homoeopathy).
- b. Fresh registration is allowed in this Stray round with the payment of non-refundable registration fee for online application RS.500 (Rupees five hundred only)
- c. At the time of choice filling, all the candidates must pay non-refundable online processing fee of Rs. 500/- (Rupees five hundred only).
- d. At the time of choice locking candidate should pay advance tuition fee of Rs. 50,000/- (Rupees fifty thousand only) to participate in stray round or subsequent round (if any) via online bank payment portal which is not refundable.
- e. For Self-Financing AUSH Colleges, Advance tuition fee is exempted for “SC/SCA/ST/BC (Converted to Christianity) from Scheduled Caste, candidates, if annual income is less than 2.5 Lakhs” at the time of choice locking and downloading the allotment order.
- f. Candidates who are not holding any seats in AUSH course will be eligible to participate in this Counselling.
- g. Candidates who have joined in All India and State Quota seats for AUSH will not be eligible to participate in this counselling.
- h. If the seat is allocated in stray vacancy the candidate has to download the allotment order and join in the college within the stipulated date and time as mentioned in the order. To download Allotment Order the candidate should pay an additional tuition fee of Rs.15,000/- (Rupees fifteen thousand only).
- j. If the candidate fails to download the allotment order or downloaded the allotment order and fails to join the college within the stipulated date and time his/her advance tuition fees will be forfeited. **They also will not be able to participate in TN AUSH Counselling for subsequent one academic year.**

- k. If a candidate joined the college and discontinued the course the candidate should pay the Discontinuation fee of Rs.1,00,000/- (Rupees one lakh only) and the paid tuition fees will not be refunded.
- l. Allotted candidates during Stray vacancy Round, if they fail to join they will have to forfeit the Advance tuition fees. **They also will not be able to participate in Tamil Nadu AUSH Counselling for subsequent one academic year.**
- m. If it is found that a candidate is/was involved in impersonation / suppression or misrepresentation of facts and production of falsified / bogus certificates, his/her provisional allotment order will be cancelled and legal proceedings / criminal action will be initiated.
- n. If during the NEET 2025 or at any stage of allotment / admission process of AUSH Admission in Tamil Nadu 2025-2026 or in the admission process of AUSH course in Tamil Nadu 2025-2026 at the allotted College, the candidate has indulged in any case of impersonation i.e. not matching the photograph /signature / documents of the candidate etc., He/ She shall be handed over to the Police by the Principal / The Commissioner of Indian Medicine and Homoeopathy, as the case may be and the cases shall be dealt as per the Indian Penal Code for further investigation. Such candidates will be debarred permanently from appearing for the AUSH Admission in Tamil Nadu in future in addition to the cancellation of his/her candidature in the medical admission in Tamil Nadu.
- o. The Selection Committee will not be responsible for approvals obtained/annual renewals and other applicable statutory approvals of various authorities including NCISM (National Commission for Indian System Medicine) / NCH (National Commission of Homoeopathy), infrastructure and the rules and regulations of the Self-Financing Private AUSH Medical Colleges. Hence, candidates are advised to go through the respective college websites and NCISM (National Commission for Indian System Medicine) / NCH (National Commission of Homoeopathy) websites and satisfy themselves before giving their option for selection of such seats by the candidates. The Selection Committee shall neither be responsible nor shall entertain any case on the above grounds.

**Note: The vacancies arising after the stray round of counselling will be kept vacant.**

17. Counselling / Allotment for the seats newly created due to provision of seat matrix after the commencement of first round counselling by The Tamil Nadu Dr. M.G.R. Medical University or due to the orders / interim orders passed by the Honorable High Court Madras after the commencement of 1<sup>st</sup> round counselling will be done **ONLY** during the 2<sup>nd</sup> round counselling but within the cutoff date for UG Courses admission as laid down by the regulatory bodies ie., NCISM (National Commission for Indian System Medicine) & NCH (National Commission of Homoeopathy) / Ministry of AYUSH.

18. Candidates getting allotment through court orders before the cutoff date will be given a seat in the existing vacancies available at the time of existing rounds of counselling when he/she actually attends.

##### **CATEGORY - I**

**(I - A)** Olympic Games (Summer / Winter), Youth Olympic Games (Summer / Winter), Commonwealth Games and Asian Games (Games organized in 4 years frequency by the International Olympic Committee).

**(I - B)** World Championship, Commonwealth championship, World Cup- (organized in 4 Years frequency by the International Sports Federations).

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS).

##### **CATEGORY - II**

World Championship, World cup, Asian Championship, SAF Games (South Asian Games), Commonwealth championship Organized in 2 years frequency by the International Sports Federation.

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS).

Open or Invitational or Memorial or any indifferent nomenclature or title of tournaments or Championships at International level, not approved by any of the above authority will not be considered for marks.

##### **CATEGORY - III**

Asian Championships, Commonwealth Games, World cup, World Championship, Grand Prix, Grand slam - Organized in Every year by the International Sports Federation.

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS) Government of India.

1. Participation or achievement in International tournaments will be considered only with earlier achievements at National and State level tournaments. Direct participation / Selection trials / Camps any International or National tournaments will not be considered for award of marks.

2. The highest achievement in only one annual regular tournament, officially conducted in a regular manner by the member National Olympic Committee (NOCs) authorized by the International Olympic Committee (IOC) or International Sports Federations affiliated to the IOC will be considered for award of marks. The players / sports persons representing the Country in such tournaments through Indian Olympic Association (IA) or respective National Sports Federations recognized by the Ministry of Youth Affairs and Sports, Government of India or IOA will be considered for award of marks in each year.

3. Only tournaments officially recognized by the Indian Olympic Association / respective official National Sports Federations Recognized by MAYS will be considered for the award of marks (for each year) from 01.06.2021 to 31.05.2022, 01.06.2022 to 31.05.2023, 01.06.2023 to 31.05.2024 and 01.06.2024 to 31.05.2025.

4. Certificates of Participation or Achievements in tournaments, submitted along with Form I alone are eligible for marks indicated in Table (I) above (should be submitted before the last date for submission of application).

5. Players who participated in any of the categories I, II and III, in Table(I) should produce the copies of the following: -

i. VISA, Immigration entry in passport, clearance from Ministry of Youth Affairs and Sports (Government of India), Indian Olympic Association and respective National Sports Federations including BCCI.

ii. The fixture, draw, schedule of events, players' accreditation, National Medal, Merit, Diploma, Participation certificate and Form-I issued by the respective National Sports Federation and certificates signed and issued in the prescribed format by the President or Secretary General of the National Olympic Committee of the Organizing Country and International Sports Federation.

#### **4 (b). FOR NATIONAL TOURNAMENTS**

1. National tournaments should have been officially be recognized as the regular annual championship / tournament by MYAS or IOA or SAI or SDAT or SGFI Nationals conducted every year by school education department in age groups (U-14, U-17, U-19) or respective official National Sports Federation will be considered (for each year) for the award of marks.

2. Marks will not be awarded for selection trials and coaching camps.

3. Tournaments conducted by the Federations which are not recognized by the IOA or MYAS, TNOA or SDAT at National level for a particular period will not be considered for award of marks.

Candidates must have participated at Zonal Cluster, District, Regional, State, National and International in a particular Game/Sport in the same hierarchical order as per the existing norms applicable for a particular Game/Sports.

#### **4 (c) FOR STATE TOURNAMENTS**

1. State level tournaments should officially be recognized as the regular annual championship or tournament by respective official State Association or SAI or SDAT or School Education Department of Tamil Nadu will be considered (for each year) for the award of marks.

2. Marks will not be awarded for selection trials and coaching camps.

3. Any tournaments conducted by the Association which are de-recognized by the SDAT at State level for a particular period will not be considered for award of marks. (Refer Recognized Association list attached in ANNEXURE VI)

#### **4 (d) FOR TAMIL NADU BOARD CBSE/KV SCHOOLS / CISCE - SPORTS ACHIEVEMENTS**

1. Tamil Nadu Board schools, KV / CISCE and CBSE Schools, School Zonal and School cluster level achievements will not be considered.

2. The candidates participated in the tournament conducted by CBSE and KV Schools, at Regional / South Zone are equated to Regional Level Achievements and the National Level Achievements are equated to State level of State / Matric Board Schools.

#### **5. GENERAL CONDITIONS**

1. For consideration of candidates seeking admission under the category of eminent sports person, he/she should enclose all the attested photo copies of participation certificates and the relevant forms issued by the competent sports authorities. The application along with all the sports certificates /relevant forms/documents as given in 4(a) 5, should be presented for certificate verification which will be done at Selection Committee, Commissionerate of Indian Medicine and Homoeopathy, Arumbakkam, Chennai- 600 106.

2. Participation / achievements in each academic year from 01.06.2021 to 31.05.2022, 01.06.2022 to 31.05.2023, 01.06.2023 to 31.05.2024 and 01.06.2024 to 31.05.2025 in sports / games shown in the list alone will be considered for the award of marks. National or State Level Championships or Tournaments conducted by Sports Federations or Associations recognized by MYAS or IOA or SDAT or TNOA alone will be considered for the award of marks. (Recognition of State Associations / National Federations should be relevant to the year concerned).

3. Relevant attested copies of certificates issued by the competent authorities as detailed below are to be submitted along with the application before the last date for receiving the applications.

4. Open or Invitational or Memorial or any indifferent nomenclature or title of tournaments or Championships at District or State or National or International level will not be considered for marks.

5. District or Inter-District Championship means the championships conducted by the respective recognized District or State Sports Association for the State of Tamil Nadu.

6. Direct participation or achievement at any level without participating in the qualifying level competitions such as District or State or National or direct selection conducted by District or State Sports Association or National Sports Federation to represent the District or State or National or International tournaments or championships will not be considered for award of marks.

7. For International achievements in Tennis, marks for Gold, Silver and Bronze will be awarded to players who are ranked first, second and third respectively in the ATP or WTA rankings of International Tennis Federation for awarding participation marks for the top 5 ranked players will be considered from the ATP or WTA list published by the International Tennis Federation. Necessary document and proof should be enclosed by the candidate for National or State level achievement in Tennis, marks for Gold, Silver and Bronze will be awarded to players who are ranked first, second and third respectively in the AITA or TANTA at National or State for awarding participation mark the top 5 ranked players will be considered from the list published by AITA or TANTA at National or State level based on the ranking. Necessary documents and proof should be enclosed by the candidate.

8. Certificates should be in printed form and necessary Form-I and II should be in prescribed format. (Certificates or forms issued in letter pads will be invalid).

9. All other sport disciplines in which ranking is the criteria for assessment of achievement, rules indicated in item 8 above will be applicable for the award of marks.

10. For Cricket, the annual official Championships or tournaments conducted within the country under the auspices of TNCA or BCCI at District or State or National Level alone will be taken into consideration for that year.

11. Multiple events in a particular sport must be standardized events and in accordance with the events organized by the approved International Federations.

Events newly created and not in accordance with the requirement will not be considered for award of marks.

12. Participation or achievements of candidates with nativity of Tamil Nadu who represented Tamil Nadu alone are eligible for marks under National Category•

13. Only Tamil Nadu candidates are eligible to apply for admission under Sports Quota and only the KVS and CBSE schools within Tamil Nadu are eligible for marks.

14. A Common Committee for Engineering and Medicine constituted for this purpose will rank the candidates based on the marks assigned to the certificates enclosed along with the application. Candidates with a minimum sports mark of 5 and above alone will be considered for ranking.

15. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate forms.

16. No further enclosures or certificates will be entertained after the last date for submission of completed application in person.

17. Highest achievement or participation certificates obtained by candidates at different levels such as District or State or National or International in each year along with earlier achievements should be enclosed without fail. (A candidate shall enclose a copy of all eligible certificates for scrutiny).

18. Candidates in proportion to the available seats will be called to appear before the Common Committee for Engineering or Medicine for verification of the Originals, followed by counseling after ranking.

19. If any candidate fails to produce the requisite Original Certificates or Forms, his/her place will be allotted to the candidate next in rank and so on. The consequential vacancy at the end of the rank list will be filled up from among the additional candidates according to their ranks.

20. All the highest level of participation or achievement should be supported by earlier achievements at all levels of competition.

21. Short listed candidates will be called for counselling based on their rank and branches and colleges will be allotted according to their choices from the number of seats reserved under sports quota based. Sports quota counselling will be held before the commencement of general counselling.

22. Candidates securing admissions under Eminent Sports Persons quota should sign an undertaking at the time of receiving allotment order assuring participation in sports activities in the college preferred by them.

23. Legal action would be taken on parents and candidates for furnishing bogus documents. They should ensure that the certificates obtained are from competent authorities.

24. A candidate can utilize the Sports Quota only once for Engineering or Medicine.

Now THEREFORE, this agreement witnesses and it is hereby agreed as follows:

1. The Candidate shall diligently complete his/her training for the said course at the said college, shall abide by the rules of the said colleges for the time being in force regulating the conduct of students at the said college and shall pass all the examinations prescribed for the said course by the University or the Medical Institution concerned.
2. Upon passing the final B.S.M.S./ B.A.M.S./ B.H.M.S. Examination the candidate shall serve as "Intern" for the prescribed period as laid down by Indian Medicine Central Council Act (Central Act of 1979).
3. (i) The candidate shall on demand made by the Government within two years from the date on which he/she registers himself/herself as a Medical Practitioner, serve for a period of not less than five years and in such rural areas as the Government by general or special orders specify.  
(ii) Those candidates who fail to comply with clause 3 (i) shall have to pay a sum of Rs. 3,00,000/- (Rupees Three Lakhs only) or as the Government may direct as penalty for having breach the contract in the bond.

4. During the period of Internship under clause (2) and while in service under clause (3) the candidate shall faithfully, diligently and with skill and ability perform his/her duties and observe the rules for the time being in force made by the Governor or the President as the case may be for regulating the conduct of Government Servants.
5. While in service under clause (3) the Pay and allowance and other conditions of service of the candidate shall be regulated by the rules and orders of the Government for the time being in force, for the posts to which he/she is appointed.
6. Candidates who discontinue the course on or after the last cut off date for admission process for the academic session 2025-2026 and on any date of the subsequent years are bound by the bond and thereby they shall have to pay a sum of Rs.1,00,000/- (Rupees One lakh only) as penalty for having breached the contract in the bond by means of Demand Draft in favour of "The Director of Indian Medicine and Homoeopathy, Chennai-106" payable at Chennai.
7. Any sum falling due from the candidate under this agreement shall be recovered from him/her as an arrear of land revenue.
8. 



**Annexure – XV**  
**FAQ'S REGARDING COUNSELLING PROCESS**

Q.No.1: How to apply for AUSH UG Medical Degree Courses admission in Tamil Nadu?

Ans: After the NEET-UG 2025 results are out, there will be notification in the websites [www.tnayushselection.org](http://www.tnayushselection.org), [www.tnhealth.tn.gov.in](http://www.tnhealth.tn.gov.in) for application to AUSH UG Medical Degree Courses admission in Tamil Nadu. Candidates are advised to Register them to create User Name and Password after that login using their User Name and Password. Candidates are advised to read this prospectus carefully and apply through the website in Online mode only.

Note: Cost of applying online: Rs.500/- (SC/SCA/ST candidates are exempted)

Q.No. 2: I have applied online. Is this enough for getting a seat?

Ans: No. Applying online is just the first stage in the entire process. Once all the applications are received and scrutinized Eligible Merit List of Candidates (Candidates who have applied and are found eligible) will be published in the websites. After this Candidates have to register for the counselling process as mentioned in the scheme of counselling.

Q. No. 3: How do I register for the counselling?

Ans.: After the Merit List is published candidates have to register before the onset of counselling by paying the non-refundable online Processing Fee of Rs.500/- in the website after logging in using the same credentials (User Name, Password) used during the application process. Registration is allowed before Round 1, Round 3 and Stray Round and Fresh registration is not allowed before Round 2 (as this is a re-allotment Round)

Note: Counselling Registration is allowed only for already applied candidates who are in the Eligible Merit list and not for those candidates who have not at all applied to AUSH UG Medical Degree Course.

Q. No. 4: How and when I had to make the payment?

Ans: After completion of Choice filling, payment page appears automatically. Candidate can do online payment by Net Banking / Credit card/ Debit card. Only after the successful payment, candidate can submit their choice filling.

Q. No. 5: Is there any restriction for filling up number of choices of Institution (College) in choice filling form?

Ans: No, you can give as many choices as you wish during online choice filling. However, choices should be in order of your preference. There will be a common software for Government Quota / Government Surrendered seats for filling up of choices. The choices will be available based on your eligibility and application.

Q. No.6: Is it necessary to fill up the choices and lock the choices to get seat allotted? Or I will be allotted seat automatically from leftover seats?

Ans: After online registration (registration is compulsory to take part in online allotment process, before the counselling Rounds during specified registration period), you have to fill in choice of Institution/college/course in order of your preference. Once choice is filled in, it can be modified before locking it. If candidate does not lock the choice submitted by him/her, the choices already filled will be automatically locked as per counselling schedule.

Note: If the candidate does not fill choices for any college, will not be allotted any seat during the counselling

**IMPORTANT:**

Don't wait till the last minute to Register and Lock your choices. Please go through your submitted choices before locking, as once you lock the choices they cannot be modified or changed even if you have made a mistake. It may result in allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even by the Selection Committee)

Q. No. 7: Is it necessary to join allotted College of Round 1 to get chance to participate in Round 2?

Ans: No, candidates need not report or join the allotted college of Round 1 since there is free exit.

However, if they want to retain the Round 1 seat and upgrade in Round 2 they have to physically join the college of Round 1 and participate in Round 2 online.

Q. No. 8: Can a candidate participate in Round 2 without submitting fresh choices (based on choices submitted before Round-1)?

Ans: Fresh choice submission by eligible candidates, as mentioned above is necessary for consideration for seat allotment during any Round. If candidate does not submit fresh choice(s) during choice filling period, the candidate will not be considered for allotment of seat during Round- 2 and will retain the already joined seat, if any

Q. No.9: If I opt to participate in Round 2 of counselling whether my allotted seat (of Round 1) will be cancelled?

Ans: In case you are not allotted any seat in the Round 2, you will retain earlier allotted seat in Round 1 if you had joined already. However, on re-allotment of a seat in Round 2, the earlier allotted seat in Round 1 will automatically be cancelled and allotted to another candidate. Therefore, you are advised to fill in only choices which you prefer over the earlier allotted seat, for Round 2.

Q. No. 10: - What is the procedure for Round 3 Counselling which will be conducted by Tamil Nadu AYUSH Selection Committee for AUSH Medical Degree Courses?

Ans. Since reallocation is allowed in Round-3, The net vacant seats due to Not allotted / non joining, non-reporting of Round 2 and any converted seats due to lack of candidates in the particular quota and the virtual vacancies will be published in the seat matrix and eligible candidates have to **submit fresh choices** and the result will be processed as per Choice & Merit applying the rule of Reservation.

Q. No. 11: How much time will I be given to join the allotted college?

Ans: Candidates allotted seats will be required to join the allotted college/course within the stipulated time which is mentioned in counselling schedule. However, candidates are advised to join as early as possible and not to wait for last day of joining, due to different schedule of holiday (including local holidays) / working hours in various ISM Medical Colleges. Therefore, candidates are advised to contact allotted college immediately after declaration of result of counselling allotment process, to know the details. If candidate fails to join the allotted College within stipulated time, then the allotted seat will be cancelled. For Round 3 and Stray Round as there is very little time for the entire counselling process and there is no process of

reallotment/resignation, downloading of allotment order after payment of Tuition Fees will be considered as Joined. But the candidate has to report to the allotted college within the stipulated time. If the candidate does not report candidates will be treated as Discontinued and his seat will be considered vacant and candidates will forfeit the advance Tuition Fees.

Please note that under no circumstances date of joining/date of reporting can be extended by the Selection Committee.

Q. No. 12: What documents are required at the time of Joining/ Reporting to allotted College?

Ans: The following original documents (along with attested photocopies) are required at the time of joining/reporting to the allotted college:

- i. Class X Mark Sheet
- ii. Class XI Mark Sheet
- iii. H.S.C. Mark sheet or any other equivalent examination.
- iv. Transfer certificate obtained after the completion of H.S.C / equivalent examination or any other courses.
- v. Certificate for proof of study from VI Std. to XII Std for the candidates who have studied completely in Tamil Nadu.
- vi. Community Certificate
- vii. Nativity certificate.
- viii. Eligibility Certificate (if applicable)
- ix. Migration certificate (if applicable)
- x. Special Category Certificate (if applicable)

Q. No. 13: In case candidate had to apply for both Govt. Quota in SF Colleges and for management quota should the candidate pay the fee for both?

Ans. Yes. As per the policy, the candidate has to pay both the fees. In this case the candidate will have to pay fee for GQ in SF Colleges. Rs.10,000/- plus for MQ Rs.25,000/- as Advance Tuition Fee in addition to the Online Processing Fee Rs.500/- for GQ and Rs.1000/- for MQ.

Q. No.14: Will the Selection Committee bear the bank charges incurred by the candidate while registering for counselling?

Ans: No. Bank Charges if any, incurred by the candidate should be borne by the candidate only.

Q. No.15: Will the Selection Committee pay interest on the refundable Advance Tuition Fee?

Ans: No. The Selection Committee will not pay interest on the refundable Advance Tuition Fee.

Q. No. 16: If I forget my password that I have created during the process of registration, how to retrieve it?

Ans: To retrieve the forgotten password, system facilitates the following process:

The candidate is required to enter the information that candidates filled at the time of registration and then security question & answer thereon to be entered as given during New Candidate registration process. The above data submitted by candidate will be validated with the registered candidate's database. If the above entries match, then only the candidate would be permitted to enter new password to proceed further.

**IMPORTANT:**

Please keep the information same as that you have furnished on the application form confidential, and do not share the password and OTP with anybody as to register for online allotment process and submit choice you need that information. If somebody else uses that information, candidates can misuse your online registration and prevent you from taking part in online allotment process. Keep print out of application form ready for reference with you.
